SIGNIFICANT ACCOUNTING POLICIES AND NOTES TO ACCOUNTS

1. ACCOUNTING CONVENTION

The financial statements of **KAKATIYA INSTITUTE OF TECHNOLOGY AND SCIENCE** are prepared and presented on the accrual basis, on the basis of going concern so as to comply in all material aspects with applicable accounting standards in India, the accounting standards and relevant guidance notes issued by the ICAI.

2. USERS OF ESTIMATES

The preparation of financial statements in conformity with Generally Accepted Accounting Principles (GAAP) in India requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent liabilities on the date of the financial statements and the reported amounts of expenses incurred during the reporting period. Differences between actual results and estimates are recognized in the year in which the actual results are known or materialized. Any revision to accounting estimates is recognized prospectively in the current and future periods.

3. CASH AND BANK BALANCES

- Cash balances are adopted as certified by the accountant
- Bank balances are recognized as per books and reconciled with the bank statements

4. PROPERTY, PLANT & EQUIPMENT

Property, Plant & Equipment are stated at cost of acquisition inclusive of freight, duties and taxes and incidental and direct expenses related to acquisition. In respect of projects under construction, related pre-operational expenses form part of the value of the assets capitalized. Property, Plant & Equipment received by way of Donation are capitalized at values stated, by corresponding credit to Utilized grant under Reserves & Surplus.

5. INVESTMENTS:

Current Investment valued at Cost or NRV whichever is lower. Non-Current Investments are valued at Cost.

6. DEPRECIATION:

Depreciation in the books of account is provided as per the WDV method as per the rates and manner specified in the Income Tax Act, 1961.



7. PREPAID AND OUTSTANDING EXPENSES:

Expenses relating to a future period are accounted for as pre-paid expenses even though they are paid for in the current accounting period. Similarly, expenses of the current year for, which payment has not yet been made (outstanding expenses) are charged to the Income and Expenditure account for the accounting period.

8. REVENUErecognition

Tuition Fee:

Tuition Fee from the Regular Courses is recognized on the basis of fees structure approved by the Telangana Fee Regulatory Committee (TFRCC) appointed by the State Government of Telangana, for the period covered i.e., financial year 2021-22.

Investment Income:

Income on Interest bearing securities and fixed deposits is recognized on time proportion basis taking into the account the amount outstanding and the applicable rates

9. GRANTS RECEIVED

AICTE-FDP Grants Received amount incurred towards faculty development programs as per the specification by the AICTE if any amount un-spent, shown under the head Un-Utilized Grant in Reserves & Surplus

10. EMPLOYEE BENEFITS

PROVIDENT FUND

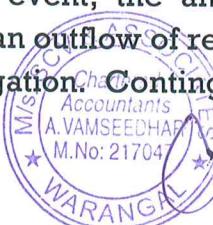
Contributions to Provident fund for eligible employees are made in accordance with the provisions of Employees Provident Fund and Miscellaneous Provisions Act, 1952.

11. CONTINGENT LIABILITIES AND PROVISIONS

A provision is recognized in the financial statements where there exists a present obligation as a result of a past event, the amount of which is reliably estimable, and it is probable that an outflow of resources would be necessitated in order to settle the obligation. Contingent liability is a



possible obligation that arises from past events and the existence of which will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Institute, or is a present obligation that arises from past events but is not recognized because either it is not probable that an outflow of resources embodying economic benefits will be required to settle the obligation, or a reliable estimate of the amount of the obligation cannot be made.

12. CURRENT ASSETS, LOANS & ADVANCES

In the opinion of the Management, Current assets, loans and advances have value on realization in the ordinary course of business, equal at least to the aggregate amount shown in the Balance Sheet.

13. All the sundry debtors, creditors, other receivables and advances are subject to the reconciliation and confirmation.

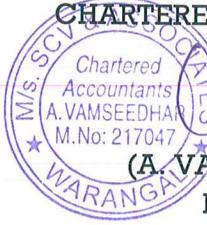

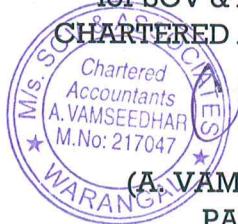
