The University has constituted an Inspection Committee to assess the infrastructure facilities available at the Department of Electronics & Communications Engineering of Kakatiya Institute of Technology & Science, Warangal, to carry out research programs leading to award of Ph.D. degree in Electronics & Communication Engineering vide KU Orders cited second. The Committee visited the department of the College on 16th May 2024 and submitted its report for further action. The Committee recommended to recognize the department of Electronics & Communication Engineering, KITS, Warangal as Research Centre and eligible faculty as listed out in the report to recognize as Research Supervisors to carry out the research programs leading to award of Ph.D. degree in Electronics & Communications Engineering by the University.

In view of the above, the Vice-Chancellor, in anticipation of approval of the Standing Committee of the Academic Senate and pending ratification by the Executive Council, has accorded approval for recognition of the Department of Electronics & Communication Engineering, Kakatiya Institute of Technology & Science (KITS) Yerragattu Hillocks, Warangal as Research Centre to carry out research programs leading to award of Ph.D. Degree in Electronics & Communication Engineering under the faculty of Engineering & Technology:

The above recognition is subject to fulfillment of the following conditions:

1. The Principal of the College should submit an undertaking to the effect that the college will continue all the research facilities originally indicated and if any short fall is found at any point of time and evaluated by the Inspection Committee at later time, the University reserves the right to revoke the recognition at any time.
2. The Department is recognized as Research Centre for a period of Five years Initially.
3. The College should pay annual recognition fee and renew its recognition every year for each discipline
4. The Recognized College should submit the detailed research facilities improved from time to time and the progress of the research work of the scholars on rolls, once in every six months to the Dean, Faculty of the discipline concerned.
5. The admissions to the Ph.D. Programs shall be regulated by the Directorate of Admissions, Kakatiya University as per the rules in vogue of this University.
6. The existing rules and regulations for admission to Degree of Doctor of Philosophy shall be applicable to the Research Centre

2. Research Scholars are allotted not more than two for the first two years and without exceeding 6 at any point of time for each supervisor
3. A supervisor shall not take his /her kith and kin as a scholar for the Ph.D. Program.
4. The Supervisors are not allowed to get guide-ship from other University (dual guide-ship). However, Co-Supervisor can be allowed in inter-disciplinary areas from other departments/Institutions with the approval of the DRC concerned.
5. Any deviation is detected at any point of time, his/her Research Supervisor-ship deemed to be cancelled.
