Subject: Grant of accreditation of one year in case of UG Engineering programs in Tier II offered by Kakatiya Institute of Technology & Science, Yerragattu Hillock, Vill., Bheemaram, Mandal, Hasanparthy, Warangal, Telangana on the basis of Compliance Report.

Sir,

This is regarding Compliance Reports submitted by **Kakatiya Institute of Technology & Science, Yerragattu Hillock, Vill., Bheemaram, Mandal, Hasanparthy, Warangal, Telangana** for the UG Engineering programs in whose case the First Cycle of accreditation of 6 years in Tier II has expired on 30.06.2020.

2. The National Board of Accreditation (NBA) has decided that in all cases of UG Engineering programs which were accredited in Tier I/Tier II in the First Cycle of accreditation for a period of 6 years upto 30-06-2020 and for which the new SAR document for Second Cycle of accreditation could not yet be finalized due to the current situation arising out of the pandemic caused by the Corona virus, the programs will be considered for accreditation of one year after expiry of the validity of accreditation on 30-06-2020 on the basis of Compliance Reports. The data submitted by **Kakatiya Institute of Technology & Science, Yerragattu Hillock, Vill., Bheemaram, Mandal, Hasanparthy, Warangal, Telangana** in the Compliance Reports has been examined and verified in NBA. Based on the same, the Competent Authority in NBA has approved the following accreditation status to the programs as given in the Table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to **Kakatiya Institute of Technology & Science, Yerragattu Hillock, Vill., Bheemaram, Mandal, Hasanparthy, Warangal, Telangana** as a whole. As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously. Complete name of the program(s) accredited, level of program(s) and the period of validity of accreditation, as well as the Academic Year from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

5. The accreditation status of the above programs is subject to change on periodic review, if needed by the NBA. It is desired that the relevant information in respect of accredited programs as indicated in the table in paragraph 2, appears on the website and information bulletin of the Institute.

6. The accreditation status awarded to the programs as indicated in table in paragraph 2 above is subject to maintenance of the current standards during the period of accreditation. If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.
