Counseling awareness programs, educating ill effects of drugs, sessions encouraging peer policing among students against drugs and reporting of any noticed use of drugs by students to authorities.
3. If anyone is found, reasonably believed to be indulging in consumption or possession or sale or purchase of Narcotic and Psychotropic drugs, the committee should inform the police.

Such information shall be kept confidential as it is classified information and cannot be disclosed to any person or authority.
