In the Ref. cited, the Director, TS Anti Narcotics Bureau, Hyderabad has informed that the Government of Telangana constituted a Telangana State Anti-Narcotics Bureau (TSNAB) on 30.04.2023, so as to combat drug trafficking comprehensively including cultivation, production, transportation, smuggling, sale, purchase, possession or consumption of Narcotics and Psychotropic Substances in the State of Telangana.

Further, it is stated that the State Level NCORD Committee has suggested for formation of Anti-Drug Committees (ACs) on par with the Anti Ragging Committees (ARCs) / Anti Ragging Squads (ARSs) in the educational Institutions Viz. Colleges, Universities etc. to educate youth on the ill effects of drug usage and legal consequences, as youngsters are the most vulnerable group and requested to issue instructions to the all educational Institutions to form Anti-Drug Committees in both Government & Private educational Institutions.

In this connection, while enclosing a copy of the letter cited, the Principals of the Professional Colleges/Government/Private Polytechnics in the State are hereby requested to form Anti-Drug Committees (ADCs) similar to Anti-Ragging Committees in their respective institutions and adhere to the guidelines issued in the letter cited for formation of the Anti-Drug Committees and furnish / upload the details of Anti-Drug Committees in their respective educational institutions' website and mail the details of Anti-Drug Committees (ADCs) constituted to <a href="mailto:tsnabho-hyd@tspolice.gov.in">tsnabho-hyd@tspolice.gov.in</a>.

It is to inform that the Government of Telangana constituted a Telangana State Anti-Narcotics Bureau (TSNAB) on 30.04.2023. Accordingly, the bureau has started functioning since 31.05.2023 at 13th Floor, Tower-B, TSP ICCC, Banjara Hills, Hyderabad to combat drug trafficking comprehensively including cultivation, production, transportation, smuggling, sale, purchase, possession or consumption of Narcotics and Psychotropic Substances in the state of Telangana and also the Government of Telangana designated TSNAB as secretariat for the State Anti-Narcotics Task Force (ANTF) vide reference 1st cited.

The State Level NCORD Committee for the 2<sup>nd</sup> time was held on 05.07.2023 and discussed on the terms of references of the Committee. As per the discussions, the Director, TSNAB suggested for formation of Anti-Drug Committees (ADCs) on par with the Anti Ragging Committees (ARCs)/Anti Ragging Squads (ARSs) in the educational institutions viz., Colleges,

Universities, etc. to educate youth on the ill effects of drug usage and legal

It is therefore, requested all the departments concerned may be directed to form Anti-Drug Committees in both Government & Private educational institutions with the following guidelines and furnish/upload the details of Anti-Drug Committees in their respective educational institution's website and to this office mail id: <a href="mailto:tsnabho-hyd@tspolice.gov.in">tsnabho-hyd@tspolice.gov.in</a>. at the earliest.

# The guidelines for formation of the Anti Drug Committees are given below:

- 1) Constitute a committee of at least 5 members to be known as the Anti-drug Committee headed by the Head of the Institution, and consisting representatives of civil and police administration, NGO involved in youth activities, faculty members, parents, students, non-teaching staff, etc.
- 2) The Institutions shall erect suitable warning hoardings/bill boards/banners in prominent places within the campus, to exhort the students not to indulge in drugs consumption.
- 3) Before the commencement of the academic session in any Institution, the Head of the Institution shall convene and address a meeting of various functionaries/agencies, such as Hostel Wardens, representatives of students, parents/guardians, faculty, district administration including the Police, to discuss the measures to be taken to prevent drugs in the Institution and steps to be taken to identify those indulging in or abetting drugs peddling/consumption.
- 4) The Institution shall give wide **publicity** among students, through various means, **about the Laws** relating to drugs and the catastrophic consequences of drug consumption.
- 5) The Committee should conduct **events** like Anti-Drugs work shop, seminars, orientation programs, counselling awareness programs, educating ill effects of drugs, sessions, encouraging peer policing among students against drugs and reporting of any noticed use of drugs by students to authorities.

8) It is hereby notified, that it shall be the overall responsibility of the Colleges and other equivalent educational Institutions and its management, to put in place other systems and checks, to eradicate the menace of Narcotic Drugs from in and around their premises.
