Ragging is totally banned on and off the campus and anyone found guilty of ragging and / or abetting ragging is liable to be punished as it is criminal offence.

In view of the directions of the Hon'ble Supreme Court in SLP No. 24295 of 2006 dated 16.5.2007 and in Civil Appeal No. 887 of 2009, dated 08-05-2009 to prohibit, prevent and eliminate the scourge of ragging, an **Anti-Ragging Committee** has been constituted to ensure compliance with the provisions of these Regulations as well as the provisions of any law for the time being in force concerning ragging; and also to monitor and oversee the performance of the Anti-Ragging Squad in prevention of ragging in the institution.
