RAGGING IS PROHIBITED

RAGGING IS AN OFFENCE TOTALLY PROHIBITED IN THE INSTITUTE AND ANY ONE FOUND GUILTY OF RAGGING AND / OR ABETTING RAGGING, WHETHER ACTIVELY OR PASSIVELY, OR BEING A PART OF A CONSPIRACY TO PROMOTE RAGGING IS LIABLE TO BE PUNISHED IN ACCORDANCE WITH UGC REGULATIONS ON CURBING THE MENACE OF RAGGING IN HIGHER EDUCATIONAL INSTITUTIONS AS WELL AS UNDER THE PROVISIONS OF ANY PENAL LAW FOR THE TIME BEING IN FORCE

All the students of II, III and IV year B.Tech., M.Tech. and MBA are hereby instructed not to indulge in any behavior or act that may be constituted as ragging under Clasue-4 of the Regulations stipulated under the ACT, vide ref (1) cited.

It is to remind all students of II, III and IV year B.Tech., M.Tech. and MBA that they have submitted signed undertaking for anti-raging at the time of registration for AY 2021-22, vide ref (10) cited.

In this connection, all the students are hereby advised to note the following punishments, imposed by the Government, to eradicate the ragging in the educational institutions. As per this act, if any student is involved in ragging,

- he may be initially suspended from the institution and
- subsequently liable to dismissal from the concerned institutions.
- Under the act, there are 10 sections and Sec. 4 of the Act vide ref (1) cited,, penalties for ragging are noted as below:

S. No.	Action	Punishment
1.	Teasing, embrassing, forcing or humiliating a student	Imprisonment up to the extent of 6 months with fine up to a maximum of Rs. 1,000/-
2.	Assaulting or using criminal forces or criminally intimidating a student	Imprisonment up to a term of 1 year with fine up to Rs. 2,000/-
3.	Wrongfully restraining or confining causing hurt to a student	Imprisonment up to a term of 2 years with fine up to Rs. 5,000/-
4.	Causing grevious hut or kidnapping or raping or committing unnatural offence to a student	Imprisonment up to 5 years with fine which may extend to Rs. 10,000/-
5.	Causing death or abetting suicide	Imprisonment for life or a term extending up to 10 years with fine extending up to Rs. 10 lakhs

Hence, all the students are strictly instructed not to indulge into any act of ragging and make KITSW ragging free institution.
