The Vice-Chancellor has accorded approval for the grant of extension of Autonomous Status to Kakatiya Institute of Technology & Science, Opp: Yerragattugutta, (V) Bheemaram, Hanamkonda for a period of Five (05) years from the session 2021-2022 to 2025-2026, including ex-post-facto for the period 2020-2021 as per provisions of Clause 3.13 and Clause 6.3 of UGC Regulations dated 12/02/2018, as extended by the University Grants Commission vide reference (03) cited.

The above College shall exercise the autonomy in accordance with the norms of the University Grants Commission, New Delhi. The College will have autonomy in framing the syllabi, scheme of instruction and examinations, making admissions, conducting the examinations within the general framework of the University. The Degrees will, however, be awarded by the Kakatiya University duly indicating the name of the College on the degree.

The extension of Autonomous Status on the College shall be subject to the rules and regulations stipulated by the UGC, New Delhi/Govt. of Telangana and Kakatiya University from time to time.
